Fifth Avenue	East	Main Street to Madison Road

IT IS HEREBY RESOLVED that the Borough hereby amends ARTICLE III, Section 205.22, Parking Prohibited at All Times, Schedule XV (§205.77), to add the following:

Fifth Avenue	West	Main Street to Madison Road

IT IS HEREBY RESOLVED that the Borough hereby amends ARTICLE VI, Section 205-39, Parking Meter Zones Established, Sub-Section B, Ten-Hour Zones, to remove the following:

Name of Street	Side	Location
Liberty Street	North	Ninth Avenue (now Arnold Avenue) to Third Avenue

IT IS HEREBY RESOLVED that the Borough hereby amends ARTICLE VI, Section 205-39, Parking Meter Zones Established, Sub-Section B, Ten-Hour Zones, to add the following:

Name of Street	Side	Location
Liberty Street	North	Ninth Avenue (now Arnold Avenue) to Fourth Avenue

All Ordinances or parts thereof in conflict herewith be and the same are hereby repealed.
