

**PUBLIC NOTICE**  
**FFY 2018 CLARION COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**  
**OBO CLARION BOROUGH – PROPOSED CHANGE OF ACTIVITY**

The Borough of Clarion hereby gives notice that it is proposing to replace the Neighborhood Park Project activity contained in the FFY 2018 Clarion County Community Development Block Grant (CDBG) application with the Main Street Improvement Project activity. No changes in FFY 2018 CDBG funding will occur. The following is a breakdown of the proposed use of CDBG funds on behalf of Clarion Borough: Main Street Improvement Project - \$82,717.00, Administration - \$18,034.00, Total - \$100,751.00.

The proposed Main Street Improvement activity is intended to both preserve and enhance the usefulness of the Borough's downtown business district, increase its attractiveness, and maintain its necessary physical infrastructure. No displacement of families or individuals will take place as a result of this change in activities. The Main Street Improvement activity is contained in the Clarion Borough Three Year Community Development Plan as attached to the FFY 2018 Clarion County CDBG application.

Interested persons may examine a draft copy of the Main Street Improvement activity description and related documents beginning on March 6, 2019 at the Clarion Borough Administrative Office, 1400 East Main Street, Clarion, PA 16214. Office hours are Monday through Friday, excepting holidays, from 8:00 a.m. to 4:00 p.m.

A public hearing will be held on March 13, 2019, beginning at 5:30 p.m., prevailing time, at the Clarion Borough Administrative Office, 1400 East Main Street, Clarion, PA 16214. The purpose of the hearing is to describe, review and discuss the above proposed activity change and to solicit public comments and suggestions. All interested persons are strongly encouraged to attend. The County has established goals of 5.0% for minimum participation by Minority Business Enterprises and 3.0% for Women Business Enterprises from the non-administrative portion of the FFY 2018 CDBG program funds.

The proposed activity change will be considered for final approval by the Clarion Borough Council at its meeting beginning at 7:00 p.m., prevailing time, on March 19, 2019 at the Clarion Free Library, 644 Main Street, Clarion, PA 16214.
